Welcome from President and meeting called to order at 7:30pm.

1. Minutes from the AGM May 3, 2018 were not posted to the Website and were not adopted.
2. Treasurers Report was read. Motion to adopt financial statement by Nirene Mijkes, seconded by Ken Salmon... Carried
3. The Charity Shoot raised over \$2000 for AARCS (Alberta Animal Rescue Society), With Michaela raising \$1085 herself by selling tickets on a beautiful handmade blanket. Shoot winners were Jason Rudolph and Nathan Osmond, with second going to Jason and Patrick Thorpe. As a note, Patrick and Nathan will be going to the Youth Nationals. Good luck to them.
4. Paula Colson (VP) asked that if anybody has a complaint about another dart player to please bring it to the Executives attention instead of posting it on our Facebook page.
5. There was no Old Business arising from the minutes as they were not read.
6. New Business: Banquet Tickets
Banquet ticket pricing is currently \$15 for members, \$20 for Spouses, and \$25 for guests.
